is made and entered into effective as of the date of purchase (the "Effective Date"), by and between HemaDAO (hereinafter known as the "Licensor") and the NFT Buyer or Holder (hereinafter known as the "Licensee") of the copyrightable permissible work ("Permissible Work").

DEFINITIONS

"Agreement" means the entire content of this document.

"God of Crypto" shall mean and refer to Licensor's creation of a unique digital collectible, also known as a NFT. "NFT" shall mean any blockchain-tracked, non-fungible token, also referred to as a 'token.'

"Permissible Work" shall mean the visual, literary, dramatic, artistic, and subject-matter works and content tied to the God of Crypto. OWNERSHIP RIGHTS
